City staff are pleased to be coming back to you for a work session on May 12, 2020 to continue to discuss potential amendments to the River Plan / South Reach. As you will recall, you held a hearing on February 25 and then a work session on March 10.

Recommended Procedure for May 12

For each of the topics listed on the following agenda, staff has prepared a Decision Table containing one or more amendments staff supports - and also some that staff recommends against. We haven't written the actual code language yet, so these amendments are still conceptual. Once we have direction from the PSC on which amendments to include in the final package, we'll prepare code language for review and approval at your May 26 work session.

Staff has already indicated (with a check mark in second to the right column) the items we expect to discuss at the meeting. If there are any un-checked items you would like to discuss, please try to let us before the meeting so we can add them to our discussion list. Staff recommends that the PSC do one straw poll on all of the remaining unchecked (non-discussion) items. If you support the unchecked items that means that you support staff's recommendation. Then staff recommends going through the discussion items one by one, straw polling on each. The memos are intended to help the PSC understand staff's thinking and the basis for our recommendation.

Staff will be prepared to walk you though all of the items that are checked for discussion. If you would like to discuss un-checked items or topics that are not on the list, please let us know in advance so we can be sure to have everything at our fingertips we need to help address questions that you might have.
