### ORDINANCE No. 115597

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for furnishing Pump No. 4 and accessory equipment at the Yeon Sewage Pumping Station for the Department of Public Works, authorizing a contract therefor, authorizing the drawing and delivery of a warrant or warrants, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the Purchasing Agent hereby is authorized and directed to advertise and receive proposals for furnishing Pump No. 4 and accessory equipment at the Yean Pumping Station, including installation thereof, for the Department of Public Works, in accordance with the plans and specifications therefor filed in the Bureau of Purchases July 30, 1962, which plans and specifications hereby are adopted and by this reference made a part of this ordinance.

Section 2. The Mayor and the Commissioner of Public Works hereby are authorized and directed to enter into a contract with the lowest responsible bidder for the project mentioned in Section 1 hereof. The Council hereby reserves the right to reject any and/or all bids, and in the event no satisfactory bid is received, the Purchasing Agent hereby is authorized to readvertise therefor until a satisfactory bid is received. The Mayor and Auditor hereby are authorized to draw and deliver a warrant or warrants chargeable to the appropriation Sewage Disposal Fund (6350), when demand is presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that there may be no delay in providing authority for the installation mentioned in Section 1 hereof, therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
