An Ordinance authorizing purchase of Lot 2 and the South 25 feet of Lot 3, Hill Grove, located at 8914 S.W. 17th Avenue from Austin Kranenberg and Eva M. Kranenberg for the sum of \$11,000, to be used in connection with the Marigold Water Tank, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that it is desirable to purchase Lot 2, and the South 25 feet of Lot 3, Hill Grove, located at 8914 S.W. 17th Avenue, for use in connection with the Marigold Water Tank which is to be erected on adjoining property; that Austin Kranenberg and Eva M.
