

## ORDINANCE No. 124069

An Ordinance designating and assigning portions of certain park and playground property to the public for street purposes for the widening of the southwest corner of S.W. Barbur Boulevard and S.W. Sheridan Street, and declaring an emergency.

The City of Portland ordains:

Section 1. It appearing to the Council that the parcel of land herein described constitutes a portion of a tract of land owned by the City of Portland in fee simple without restrictions for the benefit of the Park and Playground Fund; that the parcel of land herein described is required for the widening of the southwest corner of S.W. Barbur Boulevard and S.W. Sheridan Street, and such will contribute to the public convenience by providing better traffic flow; now, therefore, the following described parcel of property is hereby designated and assigned to the use aforesaid. Said parcel of property to be used for the purposes herein mentioned is more particularly described as follows:


A tract of land in Section 9, T.1S., R.1E. W.M., City of Portland, County of Multnomah, State of Oregon, to wit:

Beginning at the intersection of the south line of S.W. Sheridan Street as laid out 60 feet in width, with the west line of S.W. Barbur Boulevard as laid out 100 feet in width; thence West along the south line of said S.W. Sheridan Street 78.69 feet; thence easterly and southerly along the arc of a 99 foot radius curve to the right having a central angle of  $53^{\circ} 09' 18''$  a distance of 91.84 feet (the long chord of which bears S.  $63^{\circ} 25' 21''$  E. 88.59 feet) to a point on the westerly line of said S.W. Barbur Boulevard; thence N.  $0^{\circ} 45'$  W. along the westerly line of said S.W. Barbur Boulevard 40.64 feet to the point of beginning.


Section 2. That the Auditor is hereby directed to have a certified copy of this Ordinance placed on record, and a copy of said Ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: the use of said property for street purposes is needed without delay; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
