ORDINANCE N O. 128096

An Ordinance amending City Contract No. 12227 with Goldie Gentle Construction, Inc. for construction of the N.W. Kittridge Avenue Bridge by increasing the contract amount to \$46,388, providing for acceptance of the work and payment therefor upon conditions, waiving any delinquency in time of performance and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that under date of May 24, 1968, the City entered into an agreement with Goldie Gentle Construction, Inc., being City Contract No. 12227 for construction of the N.W. Kittridge Avenue Bridge approaches; that the original contract price was \$34,444.10; that during the course of construction, additional work at a total increase in the contract price of \$11,943.90 was authorized; that the work has now been completed and such contract should be amended to reflect the increased contract price and to waive any delinquency in the time of performance; that such work should be accepted and payment to the contractor authorized upon condition that the bonding company, which provided the surety bond for this contractor and contract, accept in writing the increased contract price on its performance bond and agree to be bound thereby to the full extent of the contract as amended at the increased price; now, therefore, City Contract No. 12227, between the City and Goldie Gentle Construction, Inc. for construction of the N.W. Kittridge Avenue Bridge approaches, is hereby amended to provide for an increase in the total contract price from \$34,444.10 to \$46,388, and the delinquency in time of completion of such agreement is hereby waived and the work thereunder accepted by the Council, and that payment to the contractor be authorized in the increased amount upon the condition that prior to such payment, the contractor shall cause to be filed with the City, in form approved by the City Attorney, an acceptance by the bonding company of the contractor of the increased amount of the contract and agree to be bound in the total amount as increased upon its performance bond.

Section 2. Subject to the condition expressed in Section 1 of this ordinance, this ordinance shall be an effective amendment to said contract with Goldie Gentle Construction, Inc. as such time as the contractor shall file a written acceptance of the provisions of this ordinance, approved in form by the City Attorney.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of




