#### ORDINANCE NO.

123606

An Ordinance changing the name of a certain portion of N. Columbia Blvd. to N. Columbia Court; changing the name of a certain portion of N. Walker St. to N. Columbia Blvd.; designating a newly constructed street as being a portion of N. Columbia Blvd.; defining the southerly limit of N. Portland Road and defining the easterly limit of N. Swift Blvd., all in the vicinity of the N. Swift Blvd.-N. Portland Road Interchange, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Multnomah County, in cooperation with the City and the State of Oregon Highway Department, is now in the process of relocating and widening certain portions of N. Columbia Blvd. in the vicinity of the N. Swift Blvd.-N. Portland Road Interchange, that in connection with said relocation and widening the names of certain streets should be changed and the limits of certain other streets should be re-defined in order to avoid confusion and to provide continuity in street names in this area, that Multnomah County's Director of Public Works has heretofore approved of the street name changes as proposed by the City Engineer and as appears in this ordinance, and the Council finds that such changes should now be made and such limits should be re-defined with no further delay, now therefore

1. That portion of N. Columbia Blvd. extending northeasterly and easterly from the intersection of N. Walker St. with N. Carey Blvd., to its intersection with relocated N. Columbia Blvd. near N. Woolsey Ave. is hereby changed and shall hereafter be known as N. Columbia Court.

2. That newly constructed street generally following the easterly extension of N. Walker St. and extending from the east line of N. Portsmouth Ave., thence easterly to its intersection with existing N. Columbia Blvd. near N. Woolsey Ave. shall hereafter be known as N. Columbia Blvd.

3. That reconstructed and widened street extending westerly from N. Carey Blvd. at N. Walker St., to the N. Swift Blvd.-N. Portland Road Interchange, thence southwesterly following existing N. Columbia Blvd. as now established, shall hereafter be known as N. Columbia Blvd.

4. That portion of N. Walker St. lying between N. Carey Blvd. and the easterly line of N. Portsmouth Ave. is hereby changed and shall hereafter be known as N. Columbia Blvd.

5. That certain street now designated as N. Portland Road shall hereafter terminate at its southerly end at the north line of the N. Swift Blvd.-N. Portland Road Interchange.

6. That certain street now designated as N. Swift Blvd. shall hereafter terminate at its easterly end at the westerly line of N. Swift Blvd.-N. Portland Road Interchange.

### ORDINANCE No.

Section 2. Nothing contained in the ordinance shall in any way affect the validity of any proceedings for the improvement, opening, laying-out, establishing or widening of the above-mentioned streets, or for the construction of sewers or water mains, or for the establishment of grades thereon, but such proceedings shall continue and be completed as though the name of said streets had not been changed or fixed.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That there should be no unreasonable delay in renaming certain streets and re-defining the limits of certain other streets, therefore, an emergency is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
