An Ordinance accepting two sewer easements for the N. St. Louis Avenue, N. Decatur Street and Private Property, Storm Sewer System, and declaring an emergency.

The City of Portland ordains:

Section 1. That the following described easements be and are hereby accepted for sewer purposes:

A. A strip of land in the James John Addition, a duly recorded plat in the City of Portland, County of Multnomah and State of Oregon being 20.0 feet in width and lying 10.0 feet on each side of the following described line:

Commencing at the most easterly corner of Block 8, in said James John Addition; thence S 34°00' E (plat bearing) along the southeasterly extension of the northeasterly line of said Block a distance of 27.0 feet to the point of beginning of the line to be described; thence S 56°00' W parallel to the southeasterly lines of Block 7 and 8 in said James John Addition a distance of 460.0 feet to a point which bears S 34°00" E a distance of 27.0 feet from the most southerly corner of said Block 7.
