ORDINANCE No. 131550

An Ordinance amending Chapter 20.12, Prohibited Conduct, of the Code of the City of Portland, Ordinance No. 130672, by adding thereto a new section with reference to erection of temporary structures in parks.

The City of Portland ordains:

Section 1. The Council finds that provision should be made for the prohibition of erection of temporary structures in parks; that such prohibition is consistent with the intent by the Council for uses of parks, and that Chapter 20-12, Prohibited Conduct, of Ordinance No. 130672, Code of the City of Portland, Oregon, passed by the Council April 1, 1970, as thereafter amended, is hereby amended to add thereto a new section to be numbered, entitled and to read as follows:

Section 20.12.380. Structures in Parks.

Unless authorized by a written permit from the Commissioner in charge, and subject to the terms of said permit, it is unlawful for any person to excavate for, to erect or install, or to do any act as a part of or commencement of excavation, erection, or installation for, a permanent or temporary structure or facility in or on any park or public property.

This section shall not be deemed to prohibit the erection of permanent or temporary covering or shelter in places designated by park authorities for such purposes and subject to park regulations applicable to such designated places.
