ORDINANCE No. 136980

An Ordinance abolishing the Arts Commission in lieu of the creation of the City-County Arts Commission, repealing Chapter 3.64 of Title 3, Administration of the Code of the City of Portland, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that it has been recommended by the Mayor and approved by the Commissioner in charge thereof that the Arts Commission established under Chapter 3.64 of the Code of the City of Portland be abolished in lieu of the creation of a City-County Arts Commission; now, therefore, the Arts Commission established by Chapter 3.64 of the Code of the City of Portland is hereby abolished and Chapter 3.64 of Title 3, Administration, of the Code of the City of Portland is hereby repealed in its entirety.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in the creation of a new City-County Arts Commission; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
