ORDINANCE No. 139338

An Ordinance repealing Ordinance No. 134406, which changed from Zone A2.5 to Zone C2 for Lot 9, Block 11, Southern Portland, located at 0606 SW Nebraska Street, petitioned for by Arnold and Ruth C. Hopfer, deedholders, under certain conditions, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 134406, passed by the Council April 19, 1972, changed from Zone A2.5 to Zone C2 for Lot 9, Block 11, Southern Portland, located at 0606 SW Nebraska Street, petitioned for by Arnold and Ruth C. Nebraska Street, petitioned for by Arnold and Ruth C. Hopfer, deedholders, under certain conditions, and declaring an emergency," hereby is repealed.

Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there be no unnecessary delay in clearing City records; the efore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
