

## ORDINANCE No. 142071

THE COMMISSIONERS VOTED

An Ordinance transferring \$388.74 within the Sister City Fund from Sister City, Miscellaneous, Object 659, to Sister City, Out of Town Travel, Object 632, to adjust appropriations among line items, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Sister City Fund requires an appropriation of \$388.74 within its Out of Town Travel Budget for travel costs which were budgeted and appropriated in Object 659, Miscellaneous.

2. Funds for Out of Town Travel are available within the Sister City budget in Miscellaneous, Object 659.

NOW, THEREFORE, the Council directs:

- a. \$388.74 is transferred within the Sister City budget, BUC 40500014, from Miscellaneous, Object 659, to Out of Town Travel, Object 632.

Section 2. The Council declares that an emergency exists because the appropriation is needed immediately in the account to which it is to be transferred, in order to ensure compliance with the City of Portland Budget Ordinance; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
