ORDINANCE No. 144178

An Ordinance amending Ordinance 144047 which vacated N.E. 26th Avenue between N.E. Pacific Street and N.E. Oregon Street, to make proper reference to a street to be widened at the expense of the petitioner as a condition to the vacation, and declaring an emergency.

The City of Portland Ordains:

Section 1. The Council finds:

- a. That by Ordinance No. 144047, the Council vacated N.E. 26th Avenue between N.E. Pacific Street and N.E. Oregon Street subject to certain conditions.
- b. That it was intended as a condition to said vacation, that the petitioner agree to pay all costs of roadway widening on the east side of N.E. 25th Avenue between N.E. Oregon Street and N.E. Pacific Street, and on the west side of N.E. 27th Avenue between N.E. Pacific Street and N.E. Sandy Blvd.
- c. That because of a typographical error, Condition No. (6) of Ordinance 144047 called for the widening of the east side of N.E. 26th Avenue rather than N.E. 25th Avenue as was intended, and said Ordinance should now be amended to make proper reference to the streets to be widened.

NOW, THEREFORE, the Council directs:

- 1. Condition b.(6) of Section 1 of Ordinance 144047 is hereby amended to read as follows:
 - (6) The petitioner agrees to pay all costs of intersection closures at the north and south ends of the portion of N.E. 26th Avenue to be vacated, and also to pay all costs of roadway widening on the east side of N.E. 25th Avenue between N.E. Oregon Street and N.E. Pacific Street and the west side of N.E. 27th Avenue between N.E. Pacific Street and N.E. Sandy Blvd., all in accordance with plans to be furnished by the City Engineer.

Section 2. The Council declares an emergency exists, because a delay in amending a street vacating ordinance could cause a delay in developing commercial property; therefore this Ordinance shall be in force and effect from and after its passage by the Council.
