



## **Archaeological Resource Protections**

- 2018 Tribal Summit

- Discussions with SHPO, LCIS and BIA



## **Archaeological Resource Protections** 33.475.245

- 1. Archaeological survey required prior to ground disturbing development
- 2. If resource found:
  - Site investigated
  - Depending on impacts and resource type, development may proceed
  - Some proposals require resource recovery plan and MOU with SHPO and tribe

## **Archaeological Resource Protections** [C-1, C-2, C-3]

#### Staff Recommendations

- Allow for Washington based tribes with interest in Portland land
- Commentary should state code supports state and federal policies and laws
- Consistency with SHPO practice and terminology

### New Item B-18

Commissioner Houck proposes a new Recreation action:

The City of Portland will work with the Oregon Department of State Lands (DSL) and Ross Island Sand and Gravel to explore ways to regain public ownership of submerged private lands in the Willamette River and Holgate Channel."

Lead: PPR, Partners: DSL, Private Timeframe: 6-20 years

## Residential Docks [B-11]

#### **Staff Considerations**

- Reduce environmental impacts
- Expand river area for public recreation
- Clarify review and approval of residential docks
- Limited number of new docks, address significant repair and replacement of existing docks

## Residential Docks [B-11]

#### Staff Revised Recommendations

- 1. Revise new dock development standard to: update purpose statement, and limit size and location of floating dock structures
- 2. Update exemption for normal repair and maintenance; trigger River Review and dock development standard if repair to dock is > 50% of the structure

## Residential Docks [B-11]

### Staff's Revised Recommendations (continued)

- 3. New River e development standard for replacement docks
- 4. Reorganize approval criteria section, delete fee-in-lieu reference, add one criteria
- 5. No new action needed to implement fee inlieu program

## Enforcement [A-9, A-10]

#### Staff Recommendation

- Update tree and vegetation removal standards and Option 2 for correcting violations to require proof of compliance for 3 years
- Add similar requirement for 3 year compliance in mitigation standards
- In River Review, clarify expected outcome of the operation and long-term maintenance plan and require annual monitoring reports for up to 5 years

## Enforcement [A-9, A-10] Motion

I move to amend Volume 1 of the Proposed Draft to be consistent with the following recommendations Memo A-10, Part 2:

- Recommendation #2 Mitigation standards: require projects to provide written proof of compliance to BDS for 3 years
- Recommendation #3 River Review: clarify expected outcome of the operation and longterm maintenance plan and require annual monitoring reports for up to 5 years
