## BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, THAT MULTNOMAH COUNTY, a political subdivision of the State of Oregon, grantor, without payment of compensation, pursuant to Oregon Revised Statute 275.330, does hereby grant, bargain, sell and convey unto the CITY OF PORTLAND, OREGON, a municipal corporation, grantee, its successors and assigns, all the following real property with the tenements, hereditaments and appurtenances, situated in the County of Multnomah and State of Oregon, bounded and described as follows, to-wit:

A tract of land in Section 23, Township 1 North, Range 2, East of the Willamette Meridian, in County of Multnomah and State of Oregon, described as follows:

Beginning at the Southwest corner of Section 23, Township 1 North, Range 2, East of the Willamette Meridian; thence North 1°07'45" East a distance of 471.64 feet to the South line of Beech Street; thence North 89°25' East along said South line 1,155.0 feet to the Northeast corner of Lot 1, Block 5, Beechway Addition and the true point of beginning of the tract herein described; thence North 89°25' East a distance of 1.49 feet; thence along the arc of a 250 foot radius curve to the left (the long chord of which bears North 65°55' East 199.37 feet) a distance of 205.08 feet; thence North 42°25' East a distance of 252.88 feet; thence along the arc of a 150 foot radius curve to the right (the long chord of which bears North 53°43'44" East 58.84 feet) a distance of 59.23 feet; thence South 0°37'45" West a distance of 670.56 feet to a point in the North line of Argay Terrace; thence South 89°25' West along the North line of said Argay Terrace 401.46 feet to a point on the East line of Block 13, said Argay Terrace; thence North 1°07'45" East along said East line and the prolongation of same, being the East line of Block 5, Beechway Addition, a distance of 371.02 to the true point of beginning.

## ORDINANCE No. 156756

An Ordinance authorizing acceptance of a correction deed from Multnomah County for Beech Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The City of Portland recently annexed a portion of unincorporated Multnomah County known as Argay Terrace.
- Included in Argay Terrace is a park known as Beech Park which was owned and maintained by Multnomah County.
- Multnomah County has conveyed Beech Park to the City at no cost to the City.
- 4. The transfer of Beech Park is consistent with the City's Urban Services Policy and is necessary to accomplish a smooth transition from County to City services in newly annexed areas.
- The form of correction deed has been approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The correction deed of conveyance from Multnomah County for Beech Park is hereby accepted, said property being described in the form of correction deed attached hereto as Exhibit A and by this reference made a part hereof.
- Section 2. The Council declares that an emergency exists in that Beech Park is needed for recreational purposes without undue delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
