

# SPUR guiding principles

# Three guiding principles inform SPUR's development:

- 1. Prioritize support to the most vulnerable, applying a racial equity lens;
- 2. Act quickly. Leverage existing networks and assets; and
- 3. Make a difference through action, partnership and advocacy.

250+ Number of businesses supported


# Program equity & vulnerability priorities

- Small businesses owned by Black, Indigenous, and all People of Color and/or women
- Businesses that are currently open and identified in Governor Kate Brown's Phase 1 Re-Opening Plan.
- Childcare businesses (for profit and non-profit entities)

# SPUR eligibility requirements

- Business must have lost revenue due to the impacts of the pandemic.
- Business must have \$2 million or less in annual gross revenue
- Business must have 50 or fewer employees
- Business must receive sewer, stormwater, and/or water service from the City of Portland
- Business must have been in operation and in compliance with the State of Oregon registration requirements on or prior to July 1, 2019.
