ORDINANCE NO.

An Ordinance transferring from the jurisdiction of the Belinquent fee Cornditee Lets 1 and 2.

Block Sl. Sings Weights Addition to the City of Fortland, to the jurisdiction and use of the Bureau of Water Works, appropriating \$900.00 out of the Water Construction Pund, payable to the Assessment Collection Fund, authorising the Mayor and Auditor to draw a warrant, repealing Ordinance No. 62627, enctitled, "An Ordinance authorizing the Commiscioner of Public Affairs to purchase certain real property for the use of the Bureau of Water Works, appropriating \$900.00 out of the Water Construction Fund for such purpose, authorizing the Mayor and Auditor to draw a warrant in payment therefor, and declaring an emergency, passed by the Council April 20, 1932, and declaring an emergency.

The City of Portland does ordein as follows:

Bestion 1. That Lots 1 and 2, Block 21, Kings Heights Addition to the City of Portland, Oregon, be and thehereby transferred from the jurisdiction of the Delinquent Tax Committee to the jurisdiction and use of the Bureau of Water Works. To reinburse the Delinquent Tax Committee for the said real property the sum of \$900.00 is hereby appropriated out of the Sater Construction Fund and the Mayor and Auditor are hereby authorized and directed to draw a warrant on said fund for said amount, payable to the Assessment Collection Fund.

Section 2. That Ordinance No. 63487, entitled.

"An Ordinance authorizing the Commissioner of Public Affairs to purchase certain real property for the use of the Bureau of Water Works, appropriating \$000.00 out of the Water Construction Fund for such purpose, authorizing the Mayor and Anditor to draw a surrent in payment therefor, and Seclaring an overgancy, passed by the Council April 20, 1888, be and the same is hereby repealed.

Section 5. Insermed as this ordinance is necessary for the immediate preservation of the public health, peace, and safety of the City of Portland in this: That said property is now being used by

the Bureau of Nater Works and transfer of same should be immediately made, therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
