ORDINANCE Non 69488

An Ordinance sutherising the execution of a correction deed to School District No. 1, Multnomah County, Oregon.

The City of Portland does ordain as follows:

Section 1. The Council Finds that Ordinance No. 66055, passed by the Council August 1, 1954, authorized the exchange of certain city owned property therein described for property of School District No. 1, Multnomah County, Oregon, therein described, and that certain streets adjacent to the city property were vacated prior to the execution of the deed transferring said property to School District No. 1, and no mention was made in said deed of the street area, thereby clouding the title of said School District to said property; the Council further finds that said streets were vacated to make said street area available for school purposes and it was the intention to cause said street area to be deeded to said School District along with the properties mentioned in said Ordinance No. 65053, and the deed executed pursuant thereto; now therefore, the Mayor and Auditor are hereby authorized and directed to execute and deliver a deed conveying to School District No. 1, Multnomah County, Oregon, the following described property, to with

All the right, title and interest of the City of Portland in and to the following bounded and described real property situate in the City of Portland, County of Kultnomah, State of Oregon, to wit:

That portion of S E Waverleigh Boulevard here tofore vacated by Ordinance No. 66152 lying between
the Easterly line of S. E. Sist Avenue and the
Westerly line of S. E. Sist Avenue in Waverleigh
Esights; also that portion of S. E. NoLaughlin
Street herete ore vacated by Ordinance No. 65966
lying between the Easterly line of S. E. Sist
Avenue and the westerly line of S. E. Sist
Avenue and the westerly line of S. E. Sist
avenue and the westerly line of S. E. Sist
reserved in said Ordinance No. 65966 vacating S.
E. McLaughlin Street and said Ordinance No. 66152
vacating S. E. Waverleigh Boulevard to maintain,
continue, repair, reconstruct, renew, replace,

rebuild and/or salarge any sever, water main, conduit of any kind, wire, pole or any other thing used or intended to be used for any public service, if any there be, on said vacated streets or either of them.
