My topic will be participatory budgeting in Portland and defunding the police.

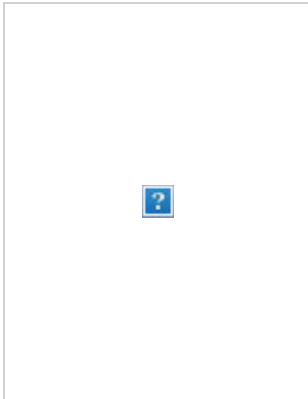
