### Re: Recommendation for Reappointment to the Development Review Advisory Committee (DRAC)

As the City's advisory body on development review, the Development Review Advisory Committee (DRAC) seeks to foster an efficient, predictable and accountable development review process. Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve up to two 3-year terms. DRAC member Michael Harrison has completed his first term, is eligible for reappointment, and has expressed interest in continuing to serve on the DRAC.

**Michael Harrison** has a background in land use planning and project management and many years' experience working with elected officials. He is the Associate Director of Local Relations at Oregon Health & Science University (OHSU), where he facilitates the operations and development activities of OHSU's various campuses. Michael has been active in DRAC subcommittees and has brought a thoughtful, collaborative approach to the DRAC's work.

Michael would remain in the Major Facilities Landowners position he has held since 2015. Michael's second term would run through January 5, 2022.
