Per City Code Section 2.08.040 and City Charter Section 2-206, the following two candidates have been nominated to the August 11, 2020 Special Election ballot to fulfill the remainder of the term for Commissioner Pos. 2: Dan Ryan (Commissioner Pos. 2) and Loretta Smith (Commissioner Pos. 2).
