ORDINANCE No. 95505

An Ordinance zoning the area in Sandberg Addition and certain adjacent Tex Lots, bounded by S. E. Washington Street and the south line of Block 7, Sandberg Addition, and between S. E. 92nd and S. E. 96th Avenues, annexed to the City of Portland by the voters at the election on November 7,1950.

The City of Portland does ordain as follows:

Section 1. The Council finds that by a vote of the electorate at the November 7, 1950 election the following described properties were annexed to and became a part of the City of Portland, and it is in the public interest that the said area be included within that area zoned by the City of Fortland under authority of Ordinance No. 77953, the Planning and Zoning Code, passed by the Council November 8, 1942; now therefore, the following described area annexed to the City of Portland by vote of the electorate on November 7, 1950, (or heretofore not zoned under the provisions of said Ordinance No. 77953) hereby is zoned as Zone I:

Beginning at the point of intersection of the east boundary line of the City of Portland and the north line of S. E. Washington Street as now laid out; thence easterly tracing the northerly line of S. E. Washington Street and its extension easterly to the westerly line of S. E. 96th Avenue; thence southerly tracing the westerly line of S. E. 96th Avenue to the southeast corner of Lot 16, Block 7, Sandberg Addition; thence westerly tracing the south line of said Block 7, Sandberg Addition to the southwest corner of Lot 1, Block 7, said addition; thence northerly along the west line of said Lot 1 to the point of intersection of the south line of Lot A, Block 7; thence westerly along the southerly line of Lot A to its intersection with the easterly line of S. E. 92nd Avenue; thence northerly along the easterly line of S. E. 92nd Avenue to the northerly line of S. E. Washington Street; thence easterly to the point of beginning.

The above description includes all of Blocks 2, 3, 4, 5, 6, and 7, of Sandberg Addition, and all of Tax Lots 225, 271, 270, 269, 180, and that portion of Tax Lots 179, 279, 6, and 255, Section 4, Township 1 South, Range 2 East., W.M., lying south of the easterly extension of S. E. Washington ORDINANCE No. 95505 Street to the westerly line of S. E. 96th Avenue.

Section 2. That the Auditor of the City of Portland hereby is directed to enlarge and add to the zoning maps provided for in Section 6-601 of the Planning and Zoning Code of the City of Portland in accordance with the provisions of this ordinance, and a certified copy of this ordinance shall be recorded in the appropriate deed record file in the office of the County Clerk for Multnomah County.
