

ORDINANCE No. 98715

An Ordinance granting a revocable permit to Clackamas Water District to install and maintain an 18-inch water pipe line in and along certain streets within the City of Portland, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that Clacksmas Water District, has through Carl E. Green & Associates, 510 Henry Building, its engineers, applied for permission to install and maintain an 18-inch water pipe line in and along the following streets within he City of Portland: Beginning at the point at which the City boundary at S.E. Boise Street crosses S.E. 100th Avenue, thence southerly along S.E. 100th Avenue to S.E. Harold Street, thence west on S.E. Harold Street to S.E. 99th Avenue, thence southerly on S.E. 99th Avenue to S.E. Henry Street, thence southwesterly on S.E. Henry Street to S.E. 97th Avenue, thence southerly on S.E. 97th Avenue to the Portland Traction Company's right of way at S.E. Glenwood Street in the City of Fortland; and that the desired permit under certain conditions will not be detrimental to the public interest; therefore, a revocable permit is hereby granted to the Clackamas Water District (hereinafter referred to as the grantee) to install and maintain an 18- inch water pipe line along City streets as heretofore set forth, the said pipe line to be located and constructed as shown on the attached plan marked "Exhibit A" and made a part of this ordinance, this permit being granted subject to the following further conditions:

- (a) Insofar as this pipe installation follows within city streets, it shall be done under the direction and to the satisfaction of the City Engineer. If after construction has begun it shall be deemed necessary or expedient to make any change in alignment or other details shown on "Exhibit A", the grantee shall, before such change is made, submit plans in quadruplicate showing such changes to the City Engineer and shall obtain the approval of such plans from the City Engineer. A copy of such supplemental plans shall be filed with the City Auditor to be attached to this ordinance for future reference.
- (b) This permit is for the use of the street area only and shall not exempt the grantee from taking out a permit from the City Engineer for opening the street or from taking out any licenses or permits required by any existing ordinances for any operation, construction or maintenance carried on under the permit hereby granted.
- (c) The grantee shall maintain the surface of said street about the said main from settlement and in the event that it shall become necessary for the City of Portland to

make any repairs to said street over said pipe because of such settlement, the grantee shall reimburse the City of Portland for the cost of such repairs.

- (d) The grantee shall protect and save harmless the City of Portland, the City Engineer, and each and all of the officers and employes of said City from any claim for damages to persons or property which may be occasioned by any construction and/or maintenance carried on under the permit hereby granted.
- (e) This permit is revocable at any time at the pleasure of the Council, and no expenditure of money hereunder, or lapse of time, or other act or thing shall operate as an estoppel against the City of Portland or be held to give the grantee any vested or other right not subject to revocation as above provided. Within thirty (30) days from any revocation of this permit, or any part thereof, the grantee shall remove the said pipe line from the street area or that part of said pipe line to which such revocation may apply, as required by and to the satisfaction of the City Engineer if required by the Council so to do.
- (f) Within ten (10) days from the date hereof, the grantee shall file with the City Auditor a document mosting the approval of the City Attorney as to form accepting and agreeing to abide by and to perform the terms and conditions hereof.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the said urgently needed water main may be constructed without undue delay; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
