

ORDINANCE No. 112796

An Ordinance naming a now unnamed street extending southerly from the south line of N.E. Multnomah Street at N.E. 16th Avenue and connecting with N.E. Lloyd Boulevard at N.E. 13th Avenue as N.E. 16th Drive and naming a now unnamed street extending southerly from the south line of N.E. Multnomah Street at N.E. 15th Avenue and connecting with N.E. 13th Avenue at N.E. Holladay Street as N.E. Holladay Way, and declaring an emergency.


The City of Portland does ordain as follows:

Section 1. The Council finds that two streets constructed to handle increased traffic in connection with the Lloyd Center Development should be named in order that they may be properly designated on City maps in order to prevent confusion in reference to traffic accidents and other traffic matters; now, therefore, that unnamed street extending southerly from the south line of N.E. Multnomah Street at N.E. 16th Avenue and connecting with N.E. Lloyd Boulevard at N.E. 13th Avenue shall hereafter be known and designated as N.E. 16th Drive and that unnamed street extending southerly from the south line of N.E. Multnomah Street at N.E. 15th Avenue and connecting with N.E. 13th Avenue at N.E. Holladay Street shall hereafter be known and designated as N.E. Holladay Way.


Section 2. Nothing contained in this ordinance shall in any way affect the validity of any proceedings for improvement, opening, laying out, establishing or widening of the above-mentioned streets or for the construction of sewers or water mains, or for the establishment of grades thereon, but such proceedings continue and be completed as though the name of the said streets had not been changed or fixed.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That there should be no unreasonable delay in designating these streets under the new designation; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
