

ORDINANCE NO. 112893

An Ordinance authorizing and directing William G. Lee, Senior Laboratory Technician, to attend a course in laboratory detection of antibiotic and pesticide residuals in milk to be held at the Robert A. Taft Sanitary Engineering Center, Cincinnati, Ohio, December 12 to 16, 1960, granting a leave of absence with pay, making a transfer of \$300, authorizing the drawing of a warrant, providing for an accounting and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that a course in laboratory detection of antibiotic and pesticide residuals in milk will be held at the Robert A. Taft Sanitary Engineering Center, Cincinnati, Ohio, December 12 to 16, 1960; that the City of Portland is being required by the Pure Food and Drug Administration to check on the presence of these materials in the Portland milk supply; that it is necessary for the Bureau of Health Laboratory to have the latest and most factual information on procedures and techniques of such detection; that Dr. Thomas L. Meador, City Health Officer, has recommended that Mr. William G. Lee, Senior Laboratory Technician, be sent to Cincinnati to attend this course, and that it would be in the best interest of the City of Portland to send Mr. William G. Lee, Senior Laboratory Technician, to Cincinnati; now, therefore, William G. Lee, Senior Laboratory Technician, is hereby authorized and directed to attend the course in laboratory detection of antibiotic and pesticide residuals in milk to be held at the Robert A. Taft Sanitary Engineering Center, Cincinnati, Ohio, December 12 to 16, 1960, and a leave of absence with pay is hereby granted to him for the period of the course together with necessary travel time.


Section 2. In order to provide funds for attendance at the course authorized in Section 1 above the sum of \$300 is hereby transferred from the General Fund, appropriation Emergency and Unforeseen Expenditures, Code No. 4100, to the General Fund, appropriation Bureau of Health, Laboratory Division, Carfare and Transportation, Code No. 932.310, and the Mayor and the Auditor are hereby authorized to draw a warrant in the sum of \$300 in favor of William G. Lee chargeable to said appropriation. It is hereby specifically provided that William G. Lee shall file with the Auditor a statement together with such vouchers as are obtainable showing the cost of transportation, hotel, meals, etc., and any remaining balance shall be returned to the General Fund and placed to the credit of the appropriation on which the warrant was drawn.



Lee for attendance at the course described in Section 1 above; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
