Francesca Gambetti Bio:

Francesca Gambetti is a Managing Partner for Shiels Obletz Johnsen, Inc. Since joining SOJ in 1998, Francesca has been involved in a variety of nonprofit, public and private projects including civic facilities, housing, school, transportation, and mixed-use development, with a focus on getting projects from concept through construction. She is adept at conducting feasibility analyses, engaging community outreach, facilitating real estate transactions, structuring and obtaining financing, obtaining public approvals, and managing all aspects of the design and construction process. Francesca has served on an array of local boards and is currently a volunteer at her children's schools and the co-founder of Scrubby Notebooks. She holds a Masters of City Planning from U.C. Berkeley, 1998 and a B.A. from Yale University, 1994.

"As a partner and project manager at Shiels Obletz Johnsen, I've been involved for over 20 years with a variety of nonprofit, public and private projects through Portland including civic facilities, housing, school, transportation, and mixed-use developments. I am deeply committed to Portland and in particular to helping our young people succeed. Peter Platt Bio:

Peter Platt is the founder and co-owner of Andina Restaurant, an award-winning, fine-dining restaurant introducing Peruvian cuisine to the Northwest. Since opening its door in 2003, Andina has been consistently recognized as one of the busiest and best restaurants in Portland and the NW region, with a mission to serve as cultural bridge between Peru and Oregon. Andina sources key ingredients directly from organic cooperatives and partner farms in Peru and commits a portion of revenues to supporting international development work throughout the country. Before opening Andina, Peter worked on new project development in Peru for Mercy Corps. Platt is the current Board Chair for Hacienda CDC, Oregon's largest Latino-centered housing provider. He holds an MBA from Yale School of Management, with a focus on social entrepreneurship, and a bachelor's degree in anthropology from Harvard University. He currently serves as the President of La Costa Verde, LLC - the holding company for Andina.

Peter Platt Statement of Interest:

"As the son of a Peruvian mother and Oregonian father, I grew up in a bi-cultural (Anglo/Latino) household and learned to be a good translator of languages and cultures. From my mother's immigrant roots and experience, I understand intimately both the drive to achieve and the need to belong. This understanding informs my commitment to listen deeply for the under-represented voices and perspectives that can best inform Prosper Portland's equity driven work, both now and in our increasingly uncertain future.

My professional story encompasses the creativity, drive and stubborn persistence to start and grow a successful family business over the past 17 years. As a business owner, I bring an operational perspective to the Prosper Portland board and a first-hand knowledge of the challenges facing small businesses – restaurants in particular – as we struggle to adapt and survive in a rapidly changing world.

I understand the vital importance of mentorship, sound management, customer acquisition skills and access to capital, particularly working capital. Now more so than ever, identifying both opportunities and the means to help provide what's missing are essential functions of Prosper Portland and its partner organizations helping to bridge the gap.

As a long-time restaurateur, I've been afforded a platform to engage with the larger food industry throughout the state and region. What I've discovered is that when we talk about "food", what we're really talking about is community. Food is a powerful symbol for the essential attributes of life that bind us to each other and to our homes. It symbolizes nature; connection back to our rural heritage; a trusting bond with the food producers and vendors that work hard to put food on our tables; the cultural traditions of our families; the true value of labor; and ultimately our sense of place in this ecosystem that we call home. I bring that mindset to my community work, including Prosper Portland's recent efforts to initiate and guide a BIPOC-led economic development strategy for our food economy that wholeheartedly embraces equity as its founding principle. I'm eager and honored to continue shaping that work and the agency's direction as a multi-cultural, anti-racist organization."

Serena Stoudamire Wesley is an Oregon Native with a passion for her community, public relations, and community engagement. Her current position is Youth Development Director, with the Oregon Department of Education. Serena's reputation precedes her in the sense that she is passionate and motivated about her work in equity and the community.

Serena has over 20 years of extensive experience building, managing, and sustaining programs. She has leadership expertise and is a proven change agent in and around the Portland/Salem metro areas. She has a knack for objectively determining resources, procuring and allocating said resources, as well as successfully implementing changes for measurable (and successful) outcomes. She has mastered program sustainability and has a proven track record in nonprofit leadership, community relations and government.

Previously, Serena held the position of Policy Director for Diversity, Equity and Inclusion in the offices of Oregon's current Governor Kate Brown.
