Dear Mayor Wheeler and Portland City Commissioners:

I am writing in support of two items on your July 22 agenda.

- 1. I support the resolution proposed by Commissioner Amanda Fritz (Item 615) to make broader use of city property, including for park space, community garden, and habitat. This will provide more equitable opportunities for access to nature and growing food in Portland's urban areas.
- 2. I support the Mayor's proposal to refer to the voters a five-year local option tax levy for the November 3, 2020 General Election to restore recreation programs and protect parks and natural areas (Item 616) These funds are needed not only to allow the re-opening of many community centers, pools, and camps, in 2021, but also maintain and enhance Portland's urban forest, and our parks and green spaces which have also been impacted by lack of funding and reduced staffing.

During the Covid-19 pandemic Portlanders flocked to local parks and natural areas to spend time in nature. There is a need to address inequities in access to nature and in distribution of tree canopy and associated benefits, including stormwater management, cleaning/cooling air and water, and reduce the impacts of urban heat island. Addressing these disparities will require funding so that the City can maintain trees in parks and natural areas, but also to continue its programs to plant trees on city streets and in yards.

Also needed is City investment in street tree maintenance, both to maintain this several billion dollar public infrastructure asset, and to reduce the cost burden on property owners that creates resistance to planting new trees and perpetuates disparities in tree canopy across the city. About two years ago, the City Council directed Portland Parks and Recreation to establish a task force to evaluate options for funding Street Tree maintenance. Unfortunately, this effort was subsumed under Sustainable Futures. It is important not to lose sight of this issue, and if the levy passes to continue moving forward toward a viable programmatic solution.

Thank you for your good work, and for considering this testimony.

RE: Testimony on the proposed PP&R levy measure

Dear Mayor Wheeler and members of the City Council,

I am writing to express support for the proposed \$48 million annual five-year levy to support operations for Portland Parks & Recreation, though with one caveat.

Our parks, greenspaces and community centers are a central part of Portland's culture for all of us. As PP&R has pointed out, the loss of community centers through closure and their underuse because of an inability to pay usage fees represents an equity issue for the City, as these public centers are us. Using voter-approved levy funding will help to address that issue.

Although I am a member of Portland's Urban Forestry Commission, the views I express here are my own, as the Commission has not discussed the levy in depth. For several years, I and my fellow UFC Commissioners have explored ways to provide public funding for street tree (in the right-of-way) planting and maintenance. Currently, the financial burden for street trees falls on the adjacent property owner. It comes as no surprise that lower income neighborhoods, especially those where people of color live, have lower canopies. High tree canopy has been shown to have a number of health benefits, including those offered by the reduction of street-level temperature afforded by shade trees.

In 2018 the City Council approved a \$100,000 budget amendment (BMP) for a study to look at public street tree issues, including how to fund it through the public sector. That funding directive became lost in the larger Sustainable Futures effort. That entire issue has been left out of the levy funding. I encourage you to include public street tree planting and maintenance as one of the PP&R efforts funded under the levy. This is an equity issue. All Portlanders should experience the health benefits, including temperature street-level temperature reduction, in the places they live and work.
