

ORDINANCE No. 154801

An Ordinance authorizing the Purchasing Agent to advertise for bids for Concert Hall Renovation for the Portland Center for the Performing Arts, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Portland center for the Performing Arts requires a construction project consisting of general construction work including related mechanical and electrical work for the renovation of the Paramount Theatre Building, referred to as the Concert Hall at 1037 SW Broadway.

NOW, THEREFORE, the Council directs:

- The Purchasing Agent shall advertise for bids using plans and specifications filed in his office on July 8, 1983 or plans and specifications as thereafter amended and filed with the Purchasing Agent prior to publication of advertisement for bids in sufficient number of copies for distribution to prospective bidders.

Section 2. The Council declares that an emergency exists because a delay in proceeding may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
