SUBJECT: Certify August 11, 2020 Special Municipal Election Results and proclaim candidate elected

Tim Scott, Director of Elections for Multnomah County, has filed in the Office of the City Auditor the abstract of votes cast at the Municipal Non-Partisan Special Run-Off Election held in the City of Portland on August 11, 2020 for the City candidates on the ballot as follows:

Per City Code Section 2.08.040 and City Charter Section 2-206, the following candidate has been elected to fulfill the remainder of the term (ending December 31, 2022) for Commissioner Position No. 2: **Dan Ryan**.

**ADDITIONAL NOTES**

Per City Charter vacancy requirements in Section 2-206, and in order to fill Position No. 2, this special election was for a run-off candidate race following a vacancy in office that occurred on January 2, 2020. The special municipal nominating election and this run-off election were authorized by City Council on January 8, 2020 by City of Portland Resolution No. 37472.

For this special election, no other candidates, measures, or jurisdictions appeared on the ballot.



The election was facilitated by Multnomah, Washington, and Clackamas Counties solely on behalf of the City of Portland.
