

ORDINANCE No. 176281

- * Accept a \$34,000 grant from the Northwest Energy Efficiency Alliance to create a case study of Portland conversion to LED traffic signal lights and share the results with other Pacific Northwest communities (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Sustainable City Principles direct City elected officials and staff to “use resources efficiently and reduce demand for natural resources, like energy . . .” and “act locally to reduce adverse global impacts of . . . ozone depletion and global warming, and support and implement innovative programs that maintain and promote Portland’s leadership as a sustainable city.”
2. The City of Portland’s Local Action Plan on Global Warming (Resolution No. 35995) establishes a goal of reducing local emissions of greenhouse gases by 10 percent below 1990 levels by 2010, exceeding the seven percent reduction target identified for the United States in the Kyoto Protocol.
3. The “Energy Efficiency in Buildings” element of the Local Action Plan on Global Warming establishes a goal of converting City traffic signals to LED technologies.
4. The Office of Sustainable Development has operated the City Energy Challenge Program since 1991. In that time period, CEC-led energy efficiency improvements have saved the City approximately \$9.75 million.
5. NEEA has requested the assistance of the Office of Sustainable Development to share the costs and benefits of LED traffic signal lamps and promote additional LED traffic signal lamp installations throughout the Pacific Northwest.
6. Compensation for City market transformation assistance through June 30, 2003 is \$34,000.
7. No additional City funding is required as match.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to sign a \$34,000 grant agreement with the Northwest Energy Efficiency Alliance.
- b. The FY 2001-2002 Budget is hereby amended as follows:
