Hello,

I am requesting to present to the city council at the next meeting.

Portland Police is documented to be using chemical weapons against Portland citizens. This includes toxic chemicals that are expired, expanding their danger and toxicity. This is not only a police issue but a public health crisis. Citizens have been repeatedly exposed to carcinogenic smoke and gasses. These are also documented to have been used in residential areas impacting families We also know this is used more often in areas that are populated by the houseless and BIPOC communities.

I hope to testify on the information we have, and call for 1) a ban on any use until PPB discloses their munitions, 2) the state of these munitions, 3) how they dispose of expired munitions, and 4) an immediate public health and environmental review, followed by 5) an investigation into PPBs use and 6) PPB to pay mitigation.
