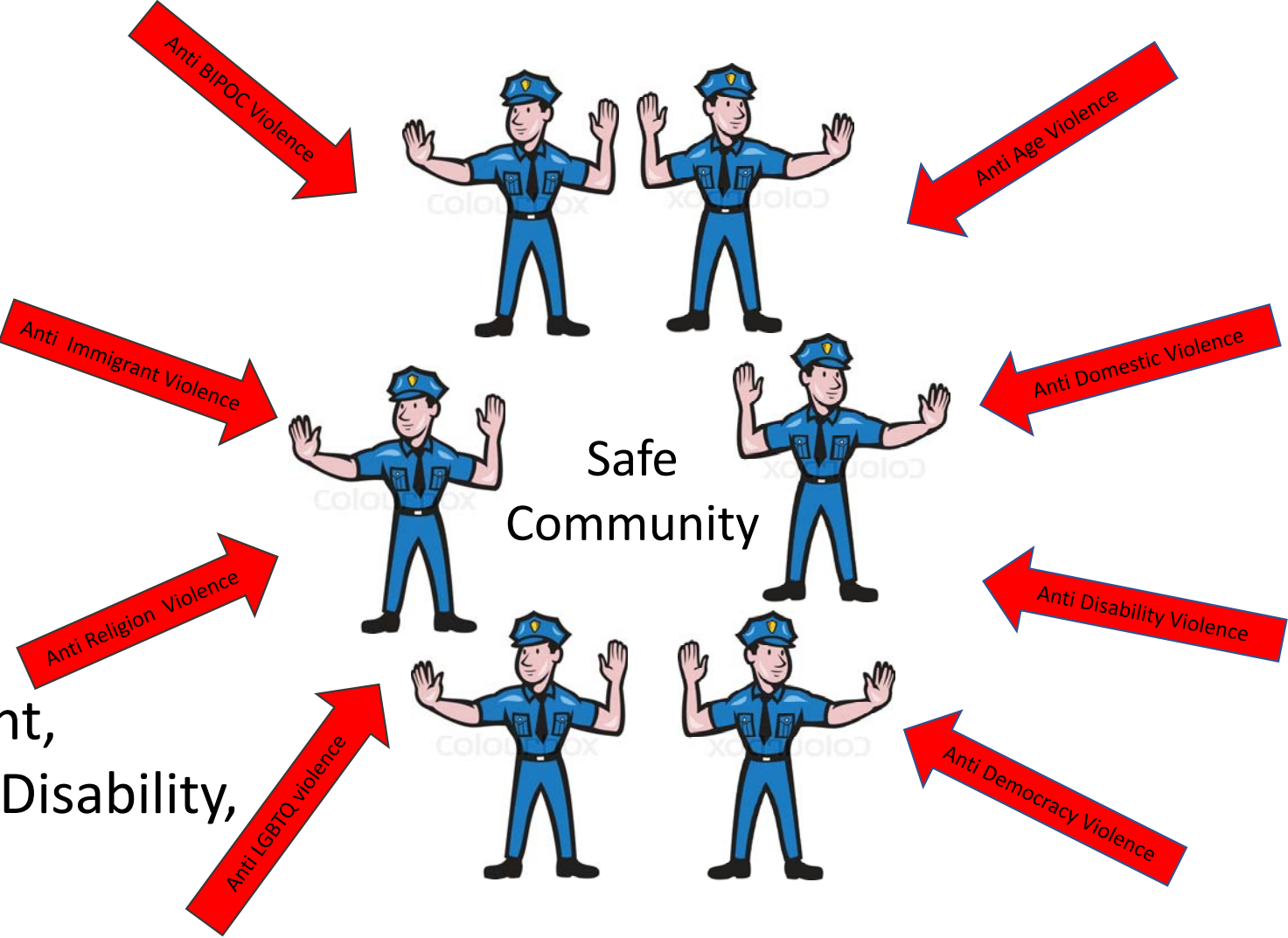

Community Response Network

Community member organizers and organizations **Respond** to and support every community's fight against reaching full social and economic equity in a **Network** of coordinated efforts to assist in public safety needs.



Success Criteria

Critical Mass –

- The numbers for whom this white male system has never favored creates fertile ground for the community-at-large to commit to defending everyone from any anti-democratic event and support anyone who has been harmed by it.

Community Responsive –

- Guidelines are collectively approved, coordinating with existing effective processes and resources, and updated to encompass new strategies for inadequate responses, and continuously improved as required.

Community Competency –

- Members are responsible for developing the CRN's competencies within their communities and to support the response in various communities as required.



Ask From Portland City Council

- Recognize the existence of grassroots support systems developed in response to PPB brutality.
- Formalize the Community Response Network infrastructure and shepherd equity and justice within member principles and policies.
- Fund this effort today!
