

# ORDINANCE No. 148989

An Ordinance creating and abolishing various positions within the Bureau of Water Works, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The positions of Accounting Assistant, Associate Accountant and Clerk II are required in lieu of the positions of Clerk III, Water Appropriations Ledger Clerk and Typist Clerk.
2. The position reclassifications are more consistent with the actual duties of the positions.
3. The Bureau of Personnel Services has reviewed and approved the action.

NOW, THEREFORE, the Council directs:

- a. The following positions are created in the Bureau of Water Works with salary rates in accordance with the current compensation plan:

1	-	0510	Accounting Assistant
1	-	0514	Associate Accountant
1	-	0112	Clerk II


- b. The following positions in the Bureau of Water Works are abolished:

1	-	0114	Clerk III
1	-	0512	Water Appropriation Ledger Clerk
1	-	0210	Typist Clerk

Section 2. The Council declares that an emergency exists because the positions to be created are immediately required in order that the operating functions may be carried out without delay, and the positions to be abolished should not be continued unnecessarily; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
