

ORDINANCE NO. 149000

An Ordinance transferring two City Planner III positions from the Housing and Community Development Appropriation Unit and one City Planner II position from the Office of Planning and Development to the Bureau of Planning; transferring one vacant City Planner III position from the Bureau of Planning to the Office of Planning and Development; reclassifying a City Planner III position in the Bureau of Planning to Chief Planner - Housing; transferring a total appropriation of \$65,470 within the HCD Fund and General Fund; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. On March 29, 1978, the Council adopted Ordinance 145472 establishing a Housing Policy for the City of Portland.
2. The City of Portland continues to face housing and housing-related needs and concerns in light of continued low vacancy rates, poor housing conditions, low income housing needs, increasing prices and interest rates, and continued public interest and concern.
3. That to effectively and efficiently respond to these and other housing related concerns and needs, the Office of Planning and Development recommends consolidating and coordinating housing planning and related functions within the Bureau of Planning.
4. As a result of this consolidation and coordination, which expands the scope and responsibility of housing planning, a reclassification of one City Planner III to Chief Planner - Housing is required.
5. That two positions currently within the Housing and Community Development Appropriation Unit and one position in the Office of Planning and Development should be transferred to the Bureau of Planning.
6. That one vacant City Planner III position should be transferred from the Bureau of Planning to the Office of Planning and Development.
7. That the appropriation transfers necessary to accomplish this consolidation are available and have been identified.

NOW, THEREFORE, the Council directs:

- a. One City Planner II position (3232) be transferred from the Office of Planning and Development (AU 500) to Bureau of Planning (AU 510) as per Exhibit B at the established compensation rate.

- b. The FY 1979-80 Budget of the City of Portland is hereby amended by transferring appropriations from the Office of Planning and Development to Bureau of Planning as follows, with line item as per Exhibit A.


