

ORDINANCE No. 149006

An Ordinance authorizing a revocable permit to allow Liberty Cable T.V., 025 S.W. Sherman permission to install a buried television transmission cable on the west property line of Hoyt Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Liberty Cable T.V. has requested permission to install a buried television cable on the west property line of Hoyt Park.
2. The Bureau of Parks finds the cable will not be an inconvenience to users of the park and therefore approves the installation.


NOW, THEREFORE, the Council directs:

- a. A revocable permit be authorized to permit Liberty Cable T.V. to install a buried television cable along the west property line of Hoyt Park as detailed on the attached plot.

Section 2. The Council declares that an emergency exists because a delay in the enactment of this ordinance will result in late completion of the described work by the petitioner; therefore, this Ordinance shall be in force and effect after its passage by the Council.
