ORDINANCE No. 149019

An Ordinance amending Ordinance No. 148749, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended August 31, 1979, by cancelling the 10% administration cost for the east 26 feet of the west 51.8 feet of Lot 5, Block 40, Caruther's Addition, and reducing the total assessment by \$32.23, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 148749, assessed the east 26 feet of the west 51.8 feet of Lot 5, Block 40, Caruther's Addition, \$354.57 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended August 31, 1979, and entered in City Lien Docket Book 124, Page 95.
- 2. The property owner has paid for the actual construction cost of \$322.34, but was unaware of the addition of 10% administration cost of \$32.23.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 148749 is amended by cancelling the 10% administration charge of \$32.23 against the east 26 feet of the west 51.8 feet of Lot 5, Block 40, Caruther's Addition, and reducing the total assessment of \$14,663.31 to \$14,631.08.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
