

ORDINANCE NO. 149026

An ordinance transferring \$17,600 in appropriation within the Housing and Community Development and General Funds for six specific projects in the Bureau of Parks; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That six projects in the Bureau of Parks have been approved for Housing and Community Development funding.
2. That additional appropriation of \$17,600 is needed in the Bureau of Parks to successfully implement these projects.
3. That the additional \$17,600 appropriation will be used on the following projects: lighting in Woodlawn Park (\$4,000); basketball court and lighting in Trenton Park (\$5,000); play equipment for Lair Hill Park (\$500); redesign 18th and Holman (\$3,100); basketball court in North Park Blocks (\$2,000); and Pioneer Church brick walkway (\$3,000).
4. That no additional resources will be needed from contingency to fund these six projects.
5. That the additional appropriation should be provided by transfer from the Housing and Community Development Fund.

NOW, THEREFORE, The Council directs:

- a. That the 1979-80 City budget is hereby amended as follows:


