

ORDINANCE No. 149038

An Ordinance repealing Ordinance No. 123499 granting a revocable permit to Irwin J. and Roslyn F. Caplan to maintain a basketball hoop in parking strip at 7339 SW Nevada Terrace, upon certain terms and conditions, waiving the provisions of Section 16-2016 of the Police Code, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That Irwin J. and Roslyn F. Caplan have sold the property and the basketball hoop is no longer located in front of the property and the ordinance allowing the revocable permit should be repealed.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 123499 entitled "An Ordinance granting a revocable permit to Irwin J. and Roslyn F. Caplan to maintain a basketball hoop in parking strip at 7339 SW Nevada Terrace, upon certain terms and conditions, waiving provisions of Section 16-2016 of the Police Code, and declaring an emergency." is hereby repealed.


