

ORDINANCE No. 149051

An Ordinance authorizing Change Order #2 in an amount not to exceed \$256,332.00 for the Transmission (Electric Power) Line for the Hydroelectric Power Project, authorizing the transfer of funds and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That additional materials and labor are necessary to construct the Transmission (Electric Power) Line due to changes in actual anchoring conditions encountered in the field.
2. That an additional appropriation of \$256,332.00 is needed for this work.
3. That Change Order #2 in an amount not to exceed \$256,332.00 is needed to Contract #18104 with Power City Construction Co. (Amelco Industries) to complete this work.
4. That a fund transfer within the Hydropower Construction Fund of \$256,332.00 is required.


NOW, THEREFORE, the Council directs:

- a. That Change Order #2 in an amount not to exceed \$256,332.00 to Contract #18104, Power City Construction Co. (Amelco Industries) be authorized.
- b. \$256,332.00 is transferred within the Hydropower Construction Fund #28 from BUC #64000012 (Hydropower Contingency), Expense Code 710 to BUC #64200003 (Hydropower Construction), Expense Code 630 (Improvements).


