

ORDINANCE No. 149064

An Ordinance amending Ordinance No. 147834, being an ordinance making an assessment for the cost, including a fee for administration expenses, of abating and removing certain nuisances for the one-month billing period ended February 28, 1979, by cancelling the assessment for Block 15, Lots 1 and 2, Berkeley, and reducing the total assessment by \$44.10, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 147834 assessed Block 15, Lots 1 and 2, Berkeley, \$44.10 for the abatement and removal of a nuisance for the period ended February 28, 1979, and entered in City Lien Docket Book 124, Page 28.
2. No recorded lien existed on this property at the time the current owner purchased the property.
3. The Bureau of Neighborhood Environment recommends that the assessment be cancelled because the owner was not made aware of the existence of any lien on his property.

NOW, THEREFORE, the Council directs:


- a. Ordinance No. 147834 is amended by cancelling the assessment against Block 15, Lots 1 and 2, Berkeley, for \$44.10, and reducing the total assessment of \$1,068.48 to \$1,024.38.


