

ORDINANCE No. 149068

An Ordinance authorizing a contract with Star Rentals of Oregon, Inc., pursuant to Bid No. 67, opened December 27, 1979, for two (2) articulated Front End Loaders for a sum of \$27,134 for the Bureau of Fleet Management, authorizing the drawing and delivery of warrants, waiving performance bond and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Purchasing Agent has advertised and received proposals for furnishing two (2) articulated front end loaders for the Bureau of Fleet Management for assignment to the Bureau of Maintenance said bids being opened December 27, 1979.
2. Star Rentals of Oregon submitted a bid in the amount of \$27,134 and was the lowest, acceptable bidder.
3. The Manager of the Bureau of Fleet Management recommends and the Commissioner of Public Utilities concurs, that a contract should be awarded to Star Rentals of Oregon.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Commissioner of Public Utilities hereby are authorized to enter into a contract with Star Rentals of Oregon, 1735 S.E. Union Ave., Portland, Oregon 97214, for furnishing two (2) articulated front end loaders, for the total sum of \$27,134, said contract shall be approved as to form by the City Attorney and a performance bond requirement from the contractor hereby is waived.
- b. The Mayor and Auditor hereby are authorized to draw and deliver to Star Rentals of Oregon, 1735 S.E. Union Ave., Portland, Oregon 97214, a warrant or warrants chargeable to the 1979-1980 Budget, Equipment (56200037/643), when demand is presented, approved by the proper authorities


Section 2. The Council declares that an emergency exists because delay in proceeding with this purchase may result in additional expenses to the City and will unnecessarily deprive the Bureau of Maintenance of the benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
