

ORDINANCE NO. 149081

An Ordinance granting a revocable permit to Stuart H. and Janice J. Lindquist to construct and maintain an oversized driveway in the westerly side of SE 18th Avenue between SE Haig and SE Rhine Street at a fee of \$426.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 17.28.110 of the City Code requires Council approval for construction of a driveway larger than the limits set forth therein.
- 2. Stuart H. and Janice J. Lindquist, owners of the property at 1730 SE Haig Street, have requested permission to construct and maintain an oversize concrete service driveway in SE 18th Avenue which is adjacent thereto.
- 3. Said driveway is to provide access to a warehouse to be constructed on said property, Building Application No. 5416, 1979.
- 4. The proposed driveway would not be detrimental to the public interest.

NOW, THEREFORE, the Council directs:

- a. A revocable permit to run with the land is granted to Stuart H. and Janice J. Lindquist, 702 SE Powell Boulevard, Portland, 97202, permittee, to construct and maintain an oversized concrete service driveway in the street area adjacent to Lots 2, 3, and 6, Block 8, Feurer's Addition and located as shown on the plan marked "Exhibit A" attached to and by this reference made a part of this ordinance, subject to the following conditions.
 - (1) This permit is for the use of the street area only, and shall not exempt the permittee from obtaining any license or permit required by the City Code or Ordinances for any act to be performed under this permit, nor shall this permit waive the provisions of any City Code, Ordinance, or the City Charter except as herein stated.
 - (2) This permit is revocable at any time at the pleasure of the Council and no expenditure of money or lapse of time, or other act or thing, shall operate as an estoppel against the City of Portland, or be held to give the permittee any vested or other right. Upon revocation of this permit by the Council, the grantee shall within thirty (30) days remove the driveway and restore the street area as required by and to the satisfaction of the City Engineer.

ORDINANCE No.

- (3) The permittee shall pay the permit fee of \$426.00 required by Section 17.24.020 of the City Code.
- (4) The permittee shall reimburse the City for the cost of filing by the City Auditor of a certified copy of this ordinance with the Records Division of Multnomah County.

Section 2. This Ordinance will not become effective until the permittee has filed with the City Auditor a document, which has been approved by the City Attorney, accepting the terms and conditions hereof.

Section 3. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in an unnecessary hardship of uncertainty on the part of the applicant as to the status of the requested permit for construction of an oversize driveway; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.


