## ORDINANCE No. 149092

An Ordinance authorizing the Purchasing Agent to sign a Purchase Order as a contract with Loren Obrist, Inc., 10037 S.E. 172nd Street, Boring, Oregon, 97009 for loading and hauling services for the Bureau of Parks at an estimated amount of \$90,000 without advertising for bids, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Parks requires hauling and loading services to remove ice storm debris accumulating in designated public collection points in various parks.
- 2. The loading and hauling services are urgently necessary for the public welfare because the amount of debris is greater than can be accommodated in the collection areas and may create hazards to public safety and traffic on adjacent streets.
- 3. This purchase has been reviewed by the Purchasing Agent. It is therefore in the public interest for Loren Obrist, Inc., to provide the necessary materials and services as set forth above at an estimate of \$90,000 without advertising for bids.

NOW, THEREFORE, the Council directs:

- The Purchasing Agent shall sign a Purchase Order to serve as a contract a. with Loren Obrist, Inc., 10037 S.E. 172nd Street, Boring, Oregon 97009 for the item mentioned in Section 1 for the total estimate amount of \$90,000 without advertising for bids. The P.O. Shall be approved as to form by the City Attorney. . - : . . .
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1979-80 budget, General Fund, Bureau of Parks, Parks Maintenance, BUC 13322228/240/5065, when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance will unnecessarily deprive the City of the benefits of completion of the contract; therefore, this Ordinance shall be in force and effective upon passage by the Council.
