

ORDINANCE No. 149096

An Ordinance reclassifying one position of City Planner III - Energy to an Administrative Assistant II in the Office of Planning and Development (Energy Office) and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Office of Planning and Development (Energy Office) is currently authorized one position of City Planner III - Energy.
2. The knowledges and skills required of this position are now more appropriately those of the Administrative Assistant II classification.
3. This action has been reviewed by the Bureau of Personnel Services.
4. That this is a downward reclassification as described in Resolution No. 32361 and therefore appropriate for Council consideration at this time.
5. Any savings realized through this reclassification will be returned through the normal quarterly allotment process.

NOW, THEREFORE, the Council directs:

- a. One position of (3234) City Planner III - Energy is abolished; and,
- b. One position of (0820) Administrative Assistant II is created in the Office of Planning and Development (Energy Office).


