ORDINANCE NO. 149098

An Ordinance changing the zoning for Lots 14-16, Block 5, Miller's Addition from C2 to R5, located on the south side of SE Miller between SE 16th and Milwaukie Avenues, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The applicants, Peter Schlechter, Joseph Z. & Marie E. Bosco, Laura Thomson, and Winifred A. Spencer, deedholders, seek a zone change from C2 to R5 for Lots 14-16, Block 5, Miller's Addition, located on the south side of SE Miller between SE 16th and Milwaukie Avenues.
- 2. A petition complying in all respects with all requirements of Title 33, Planning and Zoning, of the Code of the City of Portland and seeking such a zone change has been received.
- 3. The applicants have paid the proper fee for the filing of such petition.
- 4. The City's Hearings Officer by report and recommendation dated September 25, 1979, (PC File 6891) after and as a result of a duly authorized and conducted public hearing on September 24, 1979, made a decision of denial. The applicants appealed the decision to the Planning Commission, which on November 6, 1979, rejected the request for review. The applicants appealed the decision to the City Council.
- 5.
