ORDINANCE No. 149180

An Ordinance transferring \$27,190.00 within the General Fund from General Operating Contingency to the Bureau of Fire for Fire Apparatus services, and declaring an emergency.

The City of Portland ordains:

Section I. The Council finds:

- 1. The Bureau of Fire budgeted \$45,000.00 in FY 78-79 for the conversion of Fire Apparatus by the Bureau of Fleet Management.
- 2. Of that amount, only \$17,810.00 was expended in FY 78-79, and the balance (\$27,190.00) should be reappropriated to cover the work, which will be completed in FY 79-80.
- 3. The Bureau underexpended its Fleet line item by \$30,805.00 in FY 78-79, but requires the reappropriation of part of those funds in FY 79-80 in order to complete the work authorized last year while not foregoing the activities approved in the current budget.
- 4. The Fire Bureau not only underexpended its FY 78-79 Fleet line by \$30,805.00, but also underexpended its total Materials and Services appropriation by \$107,074.00.
- 5. In light of these underexpenditures, it is recommended that the current year's appropriations be increased by \$27,190.00 (the amount budgeted for conversions, but underspent and returned to the General Fund last fiscal year).

NOW, THEREFORE, the Council directs:

a. \$27,190.00 are transferred within the General Fund from General Operating Contingency to the Bureau of Fire.

Section 2. The Council declares that an emergency exists because the appropriation is needed in order to proceed with Council-approved Apparatus Conversion work; therefore, this ordinance shall be in force and effect from and after its passage from the Council.
