ORDINANCE NO. **149195**

An Ordinance granting a permit to the American Rhododendron Society to hold a plant sale on the Rhododendron Island, subject to certain conditions, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Philip Zeller Jr., 10933 SW Riverside Dr., Portland, Oregon 97219, Chairman of the 1980 Show, requests permission for the Portland Chapter of the Rhododendron Society to conduct a plant sale on the premises on April 5, May 10 and May 11, 1980, from 10:00 a.m. to dusk, for the purpose of raising funds for operation, maintenance, and new construction in the test garden.
2. Said sale is supported by commercial nurserymen, and the plants will be marked to distinguish them from park plants.
3. Information on care of the plants will be available to buyers during the time of sale.
4. The show is in the public interest, and it has been recommended by the Superintendent of Parks and approved by the Commissioner in charge that such permit be granted.

NOW, THEREFORE, the Council directs:

1. The Portland Chapter of the American Rhododendron Society, by Philip Zeller Jr., hereby is granted a permit to conduct a plant sale on the Rhododendron Island on April 5, May 10 and May 11, 1980, from 10:00 a.m. to dusk, subject to the following conditions:
  - a. Net proceeds of the sale after payment of all expenses shall be used for operation, maintenance, and new construction in the test garden.
  - b. A complete report of receipts and expenditures of said sale shall be made to the Commissioner in charge of the Bureau of Parks on or before August 1, 1980.

Section 2. The provisions of this Ordinance shall not be effective until a certificate of insurance approved as to form by the City Attorney has been filed with the City Auditor, affording protection for the City of Portland, its officers, agents and employees, against any claim arising out of the event as set forth in Section 1 hereof, in the single limit amount of \$300,000 per occurrence for all claims.

# ORDINANCE No.

Section 3. The permit provided by this Ordinance shall not become effective until permittee shall have filed with the City Auditor, in form approved by the City Attorney, a document in writing accepting the terms and conditions of this Ordinance.

Section 4. The Council declares that an emergency exists because delay in enactment of this Ordinance would cause unnecessary difficulty in making arrangements for the event; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
