# ORDINANCE No. 149201

An Ordinance amending Section 20.44.030(b)(2), Parks and Recreation, of the Code of the City of Portland to exempt church members of city church teams from the nonresident player limitation, and declaring an emergency.

The City of Portland ordains:

## Section 1. The Council finds:

- (1) That Section 20.44.030 of the Code of the City of Portland presently limits the percentage of nonresident players on any one team playing in a sports program administered by the Bureau of Parks;
- (2) That the limitation for nonresident players presently exempts city industrial teams from such player limitation;
- (3) That the exemption for the player limitation should be extended to church members of city church teams

# NOW, THEREFORE, the Council directs:

(a) Chapter 20.44.030(b)(2) of the Code of the City of Portland is hereby amended to read as follows:

20.44.030 Player limitation for adult teams. No change.

- (a) No change.

- (1) No change.
- (2) Subsection (a) of this section shall not apply to city industrial teams or church members of city church teams, however, nonresident players playing on such teams shall pay the nonresident fee.

### Section 2. The Council declares:

In order that the amendment authorizing exemption for church members of city church teams may be effective without unnecessary delay, therefore an emergency exists and this ordinance shall be in force and effect from and after its passage by the Council.
