

ORDINANCE NO. 149212

An Ordinance transferring \$10,165 within the General Fund from Unforeseen Reimbursable Expenditures to the Park Bureau, authorizing the purchasing agent to sign a Purchase Order as a contract with Oregon State University, Forest Research Laboratory, in the amount of \$9,735 without advertising for bids, authorizing the drawing and delivery of warrants, waiving performance bond requirements and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. By Ordinance No. 148977 Council authorized application by the Park Bureau to the Oregon State Marine Board (OSMB) for \$10,240 for construction of three marine information kiosks.
2. OSMB awarded the grant No. 8006-235A on January 16, 1980. The grant award specifies that the source of the information and construction must be Oregon State University Forest Research Laboratory.
3. The direct funds, \$10,165, should be appropriated in the Bureau of Parks for implementation of the grant program.

NOW, THEREFORE, the Council finds:

- a. The 1979-80 Budget is amended as follows:

- b. The Purchasing Agent shall sign a Purchase Order to serve as a contract with Oregon State University for the amount of \$9,735 for three marine information kiosks without advertising for bids and waiving performance bond requirements. The purchase order shall be approved as to form by the City Attorney.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to Bureau of Parks when demand is presented, approved by the proper authorities.

ORDINANCE No.

Section 2. The Council declares an emergency exists because any delay would result in loss of grant funds and needlessly deprive the City of the benefits of the completed project; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
