ORDINANCE No. 149214

An Ordinance authorizing a salary equivalent to the third year rate for the classification of Sr. Stenographer for a part-time senior stenographer in the office of the City Attorney, effective March 21, 1980, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- (1) That Joanne Adams was hired as a part-time Sr. Stenographer in the office of the City Attorney on March 21, 1979 at a rate equivalent to the second year compensation rate in the Sr. Stenographer classifica-tion;
- (2) That at the time it was intended the compensation for this position be increased to the third year rate after employment for a period of one year;
- (3) That funds are available for payment of the increase within the budget of the office of the City Attorney and no transfer of funds are required;

NOW, THEREFORE, the Council directs:

(a) That the salary rate for the part-time Sr. Stenographer position in the office of the City Attorney currently filled by Joanne Adams shall be increased to the hourly rate equivalent to the compensation for such position for full-time employes at the maximum rate of three years service, or more, effective March 21, 1980.,

Section 2. The Council declares:

That an emergency exists in order to properly compensate the individual in the office of the City Attorney for duties performed on an equivalent basis of the hourly rate for a full-time employe; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
