ORDINANCE No. 149235

An Ordinance authorizing the Purchasing Agent to sign a Purchase Order as a contract with Miller Tree Service, 3725 S.E. Clinton, Portland, Oregon 97202 for the emergency removal of dangerous hanging limbs from parks and golf courses at an estimated amount of \$30,000 without advertising for bids, authorizing the drawing and deliver of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Parks requires tree trimming services to remove dangerous hanging limbs from parks and golf courses.
- The tree trimming services are urgently necessary for the public welfare because the hanging limbs create a hazard to the public safety.
- 3. This purchase has been reviewed by the Purchasing Agent. It is therefore in the public interest for Miller Tree Service to provide the necessary materials and services as set forth above at an estimate of \$30,000 without advertising for bids.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent is authorized to sign a Purchase Order as a contract with Miller Tree Service, 3725 S.E. Clinton, Portland, Oregon 97202 for emergency tree trimming services for a total estimated amount of \$30,000 without advertising for bids. The Purchase Order shall be approved as to form by the City Attorney.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1979-80 Budget, General Fund, Bureau of Parks, R.U. 135, Park Grounds, when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because delay in proceeding with the tree trimming services would constitute a hazard to the health and safety of the citizens of Portland; therefore, this Ordinance shall be in force and effect upon passage by the Council.
